Because they lived in woodlands, animate poisoning was a typical occurrence in the past. Texts provide a detailed explanation of the Sarpa (snake), its bite, and its treatments. Because to the absence of mobility and medical services, snake poisoning deaths occur often in rural areas of this agricultural nation.
